



## Judges Information Update October 2015

### Judges Regional Seminar

The Regional seminar, which was held on Saturday 24<sup>th</sup> October, was reasonably well attended with 12 judges present. Most were Regional but there were several Candidate judges and a few from the other grades as well.

The day was spent going through the Regional re-assessment paper, the target questions in the morning and the field questions in the afternoon.

The only questions which caused any real problems were the ones regarding scoring on three spot vertical faces, so a fair amount of time was taken to go through these, explaining the procedure that has to be adopted so that you reach the correct answer.

For those of you who did not attend the seminar the sequence to follow is shown below

- Calculate the value of each individual arrow
- Where there is more than one arrow in a target face, the lowest value is taken, the other arrows are recorded as misses
- Determine scoring order of all the arrow values, including
- Record the 3 lowest arrow values
- For each arrow shot out of time you need to strike out the highest scoring value and mark it as a miss. The original value must be recorded in case there is an appeal, which if upheld will reinstate the original value.

This sequence is used for both indoor vertical faces and field vertical faces (Bunnies).

Any Regional judges who did not attend the seminar and is unsure about any of their answers, please remember you can discuss the paper with any of the other judges you may know or you can contact me if you wish.

The paper does not have to be returned until 16<sup>th</sup> November, so there is still time to seek advice if required.

### Judge Changes

During October we had three new Candidate judges join our ranks, these were Phillip Morris from Lancashire and both Jamie & Andrew Cottage from Durham & Northumberland.

As usual information on these Candidates has been sent to the registrar, and they have all been sent introduction packs.

At the end of September Ruth Hill from Lancashire retired from judging. Ruth had had been a judge since 2011 and had attained the level of Regional.

### Archery GB rule changes

Changes to the Rules of Shooting and Shooting Administrative Procedures as agreed by the Operations Committee came into effect on 1 October 2015. The new book is available to down load from the AGB website. The link below will open the PDF copy of book.

Rules 408 (b) and (d) Amended to include the use of a five spot face for a Worcester Round.

Rule 502(j)(i) Amendment to rules for shooting American Flat Bow, allowing archers to use either the Mediterranean Loose or fingers directly below the nock.
